3. Thailand Precautions

- Kanchanaburi Provincial Communicable Disease Committee allowed business owners to import and export goods and products every Wednesday and Thursday of the 2nd and 4th week of the month. The allowed categories comprise consumer goods, livestocks, land animals, aquatic animals, poultry, agricultural products, and all necessary products for daily use except for tobacco and alcohol products. The products must be transferred in the form of rear-to-rear from one cargo truck to another at the point of temporary trading relief of the Three Pagodas Pass in Sangkhlaburi district. In addition, everyone must follow the disease prevention and control measures issued by the Ministry of Public Health.
- The Department of Health Service Support (SSO), Ministry of Public Health, in collaboration with Agoda Company (Agoda), launched the world's first international Alternative State Quarantine (ASQ) packages operating system (platform). The platform helps Thais who want to return home and foreigners who are allowed to enter the country regarding the hotel booking for ASQ which makes it easier to find and compare ASQ packages in Thailand.

4. Risk Assessment of COVID-19 Situation

Monitoring of the travelers who entered the quarantine facilities in Thailand on 27 November 2020 had detected 19 confirmed cases of COVID-19. The cases were 14 Thais and 5 foreigners from Saudi Arabia (4), USA (3), 2 each from India, Germany and Georgia, and 1 each from Sweden, UK, Italy, Luxembourg, Oman and Poland. The increasing detected COVID-19 cases was corresponding to the increasing trend in many countries around the world. Therefore, the risk of foreign travelers bringing the virus into the country is still high.
