3. Thailand Precautions

- Chiang Rai province had ordered to close down the entertainment place where the seven infected COVID-19 cases were found in Muang Chiang Rai district for 14 days and closed the 3 restaurants where the infected person and friends went to eat and drink for 7 days. Now, the places are under the sterilization and cleansing process. The 3 biosafety vehicles had been used for COVID-19 laboratory detection service for people at the Singha Park, Mueang Chiang Rai District and Mae Sai District. So far, 2,121 people had been tested for COVID-19 disease from 2 4 December and 1,474 persons had negative results while 647 persons are awaiting results.
- Mae Hong Son Provincial Governor ordered the tightening measures to prevent the spread of COVID-19. The Mae Hong Son Provincial Communicable Disease Committee inspected the Ban Mae Sam Lab relief point, Sop Moei district, which is one of the five relief points bordering Myanmar. In addition, the Governor also gave a policy to adjust the Mae Lam Salween river area to be a flea market to welcome the future tourists which is a policy to support and promote tourist visits during the coming summer.
- Pichit Provincial Governor said that Pichit Provincial Communicable Disease Committee had
 a resolution to close two entertainment venues where SAR-CoV-2 infected person had
 visited for 14 days from 2 December 2020 onward. The place has been now under cleansing
 process. Coordination with the Ministry of Labor's local agency to urgently seek
 compensation criteria for entrepreneurs and employees of the entertainment places had also
 been done.

4. Risk Assessment of COVID-19 Situation

According to the continued detection of COVID-19 Thai cases traveled back from Myanmar through natural border paths in Chiang Mai and Chiang Rai, Phayao, Bangkok, Phichit and Ratchaburi provinces by official and unofficial public transports. Some of them then travelled by plane to other provinces. Some also entered crowded places such as local fairs and entertainment places where most people did not wear masks. Hence, this has created a high risk of local transmission of COVID-19 in the country. Therefore, surveillance must be strengthened in patients with respiratory symptoms especially those with risk history. The prevention of smuggling into the country and active disease surveillance in these group as well as entertainment places like pubs are crucial. The risk communication to the public to maintain strict compliance with preventive measures including mask wearing, frequent hands washing, social distancing, and scanning of Thai Chana platform must be re-emphasized. The public is also advised to follow the COVID-19 situation from the CCSA, the Ministry of Public Health and other trusted sources of information.
