3. Thailand Precautions

- Pha Muang Forces and police officers in the border area of ChiangRai province patrolled together along the land and marine borders to prevent illegal border crossing through natural border paths. The mission targets Thai people in the Tachileik township of Myanmar to return to the country via the official border checkpoints.
- Pak-Chong District Health Office, Nakhon Ratchasima province, reported prosecution against the organizer of Big Mountain Music Festival for not follow the order to close the venue and continued to hold the concert until 22.00 p.m. on 13 December 2020, which is a violation of the Communicable Diseases Act 2015, section 34 and 35.
- The Public Health Minister said that the new year countdown events are able to be organized with new normal measures by keeping social distance, checking temperature, limiting the number of participants, and publicizing all measures in advance.
- The Prime Minister requested the people to strictly follow all preventive measures including venue check-in through the "ThaiChana" platform. Venue owners are requested to provide QR code and follow the government's preventive measures strictly.

4. Risk Assessment of COVID-19 Situation

Most of the new COVID-19 cases in Thailand currently are from the quarantine facilities. There were some cases that had been positive at the second round of sample collection. One case who had 3 rounds of negative laboratory test results at a private hospital (Alternate State Quarantine, ASQ). But when he wanted to return home and came to test for the infection again, it was found to be positive. The same samples taken at the ASQ were re-examined at the Department of Medical Sciences, the results were positive. Besides, the two new infected people were found in the quarantine facilities from the same inbound flight to Thailand but from a different country of origin who did not stay in the same quarantine facility, and were seated 5 rows apart during the flight. Therefore, the laboratory quality examination Including a genomic sequencing will help determine the nature of the infection of these infected people.
