3. Thailand Precautions

- The National Buddhism Office announced the cancellation of the Buddhist Prayers Ceremony in temples across the country as the COVID-19 preventive measures. However, there will be a live broadcast of the Buddha Mantra Charity Ceremony from Wat Arun Ratchawararam Worawihan for the public to watch and join the Chittaphavana via the Television Channels (7 HD and NBT 2HD) including online media of Wat Arun Ratchawararam, National Buddhism Office, and the 9 MCOT on 31 December 2020 at 11:00 p.m. until the end of the ceremony.
- Government Gazette Office disseminated the requirements and practices to government agencies during the current COVID-19 outbreak, issued in accordance with Section 9 of the Emergencies Decree on Public Administration in Emergency Situations, B.E. 2548 (No.15) including: 1) Prohibit to enter risk areas. 2) Give power to the Provincial Governors to close risk places, and 3) Prohibit to gather in crowded places, 4) Prohibit to move migrant workers, 5) Strictly enforce the disease preventive measures. 6. is the steering unit for all government and related agencies, 7) The Provincial and the BMA Governors are commanders to solve emergency situations in accordance with the measures prescribed by the CCSA, and 8) Announcements and orders issued by the Provincial and the BMA Governors prior to this requirements and practices shall be effective as before.

4. Risk Assessment of COVID-19 Situation

Due to the new outbreaks of COVID-19 with the tendency spreading to more provinces across the country with various risk factors such as the virusstrain, close contact with asymptomatic infected persons, travelling by public transportation, and crowded places or communities. Therefore, the combined measures for prevention and control of the transmission must be implemented including maintaining personal hygiene, screening for infected people, or even locking down the risk areas. The non-pharmaceutical intervention (NPI) by the risk-area lockdown measures have been proven successful in 10 European countries (Flaxman et al.). However, the measures must be used appropriately along with other measures such as face mask wearing and maintaining personal hygiene to get the best outcomes.
