3. Thailand Imprementations

- The Department of Disease Control pointed out the risk public spots and places where special precautions should be taken, such as handrail, public toilets door knob or door handle, corporate shared phones, microphone, public transport handrail ,coins or banknotes, ATMs, working desks, shopping carts or baskets in malls or supermarkets, elevator push buttons, and public bus doors, etc.If there is a risk point exposure or shared items with others, all should immediately wash hands with soap and water or alcohol gel and avoid eating together. People should apply Department of Health’s measures which is “D-M-H-T-T” as follows; D: keep Social Distancing for 1-2 meters and avoid being in crowded places, M: wearing a cloth Mask or face Mask all the time, H: wash your Hands frequently with water and soap or alcohol gel, T: Testing for COVID-19 and measuring body Temperature, and the last T: scanning Thai Cha Na application before entering in - out of public places

every time and clean body immediately when returning home. In addition, "morchana" application is encouraged to download for timely tracking timelines of the high risk contacts.

4. Risk Assessment of COVID-19 Situation

From the surveillance of Covid-19 situation, there are various influencing factors of transmission to others. These include visiting crowded places and participating activities such as having meals together, parties, singing or shouting without wearing face masks and keeping social distance from each other. Some infected cases are asymptomatic and don't realize they are being infected. Therefore, people who have visited parties or risk places need to observe their symptoms for 14 days from the participating date. They are also requested to comply with D-M-H-T-T measures to reduce transmission.
