3. Thailand Implementations

- The Ministry of Public Health (MoPH) revealed that 29,900 people had received COVID-19 vaccine during 28 February to 8 March 2021. The MoPH also advised that people add the “MorProm” application as their friend on the Line application. The “MorProm” application will help check the names, the COVID-19 vaccine evaluation and acceptance, and send a message to remind the 2 vaccine appointment dates, follow-up on adverse effects after vaccination and provide a complete vaccination certification. The ministry also illiterates that the people must receive the complete vaccination to increase the vaccine efficacy in disease prevention.
- The Bangkok Metropolitan Administration (BMA) had unlocked its routine registration services in ffty district offices on 13 March 2021. In addition, it had also opened the Bangkok express service in 8 spots from 15 March 2021 onward. The BMA emphasized that all concerned agencies strictly implement the MoPH’s disease prevention and control measures. All agencies must identify the appropriate number of service receivers and use the online queuing system for their management.

4. Risk Assessment of COVID-19 Situation

From the Coronavirus 2019 situation monitoring system, as of 10 March 2021, it was found that Thailand has 26,540 accumulative confirmed cases of which 23,675 cases are from local transmission. There are 39 new cases today of which 34 cases are from local transmission. The data indicates that the virus has still been spreading in some areas particularly from asymptomatic cases. Therefore, the disease surveillance must be carried out continuously and the disease preventive measures must be strictly maintained. In addition, people are requested for collaboration on self-protection and reduction of the disease spreading risk by implementing preventive measures such as wearing masks, washing hands, and social distancing.
