#### 3. Thailand Implementations

• The Ministry of Public Health has started the COVID-19 vaccination services in all provinces across the country by setting up 993 vaccination centers in Bangkok (at least 25), the Social Security Office (25), universities (at least 11), and the central vaccination centers (10) such as Bang Sue Grand Station, Rajanukul Institute, Srithanya Hospital, Bangrak Health Institute, etc. The vaccination information will be recorded on the vaccine database system of the Ministry of Public Health and

MorProm Application for follow up of vaccine side effects and issuing the complete vaccination certificate.

- The Department of Disease Control reveals that most of the 1.8 million doses of AstraZeneca vaccine manufactured by the Siam Biosciences Co.Ltd. will be allocated to the BMA (the maximum control area). At first, 350,000 doses of the vaccine will be allocated and will be increased to a total of i million doses by June 2021. The vaccine will be provided to hospitals, medical facilities, and vaccination service centers outside hospitals (148). The vaccine will also be allocated all provinces for the target populations.
- The Nonthaburi Provincial Communicable Disease Committee orders a temporary closure of Sombat fresh market for another 14 days until 21 June 2021 and a partial closure of Nonthaburi Municipality market until 14 June 2021 or until the markets pass the inspection of the Ministry of Public Health's standards. The committee also orders a prohibition of setting up of stalls on sidewalks, roads, alleys, walkways or other areas.

#### 4. Risk Assessment of COVID-19 Situation

According to the Coronavirus 2019 monitoring system, as of 7 June 2021, it is found that Thailand has had 179,886 accumulated confirmed cases. There are 2,419 new cases today of which 1, 347 cases are from local transmission. There are 33 new deaths. The total new daily cases have continuously been over 2,000. Outbreaks in various risk sites especially in Bangkok and surrounding provinces have occurred in factories and crowded markets. However, the daily number of new cases in the Northern, Southern, and Northeastern regions have been on a decreasing trend. Most of the infections have occurred among family members and relatives. All provinces are advised to continue proactive case finding in high-risk areas such as prisons, markets, establishments, and densely populated communities. All provinces should be vigilant on surveillance of travelers from Bangkok, surrounding provinces and outbreak areas. A rapid elevation of the population immunity level is very crucial. According to the COVID-19 vaccination database tracking system, more than 4 million doses of the vaccine have been provided to target people including the elderly, chronic disease patients and obese people. Communication to the public to receive the complete doses of vaccine at the service centers as per the appointment has been actively provided through channels. In addition, people are advised to maintain personal disease prevention measures including wearing masks when going outside of their houses, working from home as much as possible, avoid unnecessary traveling, especially to high-risk crowded places, get together for eating or chatting.
