3. Thailand Implementations

• Thailand's Centre for COVID-19 Situation Administration (CCSA) has ordered the security forces and personnel to set up checkpoints to intercept travel in and out of the 13 provinces classified as dark-red zones, both around the periphery and routes within the area. The checkpoint officers will check for three documents which are required for travelers into and out of the areas including permission to travel,

information in the Thai Chana application and registration on the Stop COVID website (หยุดเชื้อเพื่อชาติ) to present the corresponding QR Code to the staff.

- The Department of Rail Transport announced four measures as follows to control the COVID-19 situation:
 - 1. Limit the number of passengers on trains, to not exceed 50% of the maximum capacity.
 - 2. Require passengers to prepare their identity documents and be ready for the staff to verify them.
 - 3. Increase rigor and clarity in the implementation of various measures.
 - 4. Report the operation results through the LINE application (Anti COVID-19) to expedite action in the relevant areas.

The measures are effective from July 21, 2021 onwards.

 The Civil Aviation Authority of Thailand has announced that the transport of passengers on domestic flights from entering and exiting maximum and strict control areas (dark red zones) is forbidden. The exceptions include flights related to the Sandbox campaign and emergency landings such as those for providing medical services or vaccines. The measures will start on July 21, 2021 until further changes are announced.

4. Risk Assessment of COVID-19 Situation

In the past week (from July 13-19, 2021), Thailand confirmed a cumulative number of 70,143 new COVID-19 cases. Infected people traveling from the risk areas represented 9.33%, and 40% were detected by active case finding. Many provinces with increased cases of infections were in the Northeast. This was consistent with the majority of workers returning to their hometowns following the measures that closed construction sites and worker camps. In addition, the disease control measures announced on July 12, 2021 resulted in more outward travel from Bangkok. Therefore, there may continue to be more new infected cases outside of Bangkok for at least two more weeks. For travel-related outbreaks, a study on non-pharmaceutical interventions (NPI) from the United States found that if people strictly follow the measures to limit travel, there may be a reduction in the number of infected cases by 17.5 - 35%. Therefore, if people stop traveling according to the strict measures, the number of new cases is likely to drop to less than 8,000 cases a day in the next two weeks.
