3. Thailand Implementations

- The CCSA envisioned reopening entertainment venues, including Pub, Bar and Karaoke after New Year 2022. This issue will be raised at a meeting on November 12, 2021. In addition, the Cabinet meeting considered allowing to organize the Count Down activities during the new year festival. However, the Loy - Krathong has still not been permitted to organize due to the continuation of the COVID-19 pandemic.
- Phitsanulok closed a new central and municipal (6) Market for 3 days, from November 10-12, 2021 according to a growing number of new infected cases. This averages between 80 and 90 cases a day.
- Nong Khai has measures to open the city because the province is classed as light blue zone. As such, it pilot phase 1 tourism began in four districts including Mueang

Nong Khai, Tha Bo, Si Chiang Mai and Sangkhom Districts. Activities will open at the Border Trade Service Centre, medical treatment, travel and long-term residence.

4. Risk Assessment of COVID-19 Situation

According to the information of the Global COVID -19 situation, it found more than 251 million cumulative confirmed cases (more than 400,000 cases per day). There was an increasing trend of new cases when compared to the number of mid - October due to the high number of cases in Europe. The top countries with the most infections were the United States, Russia, the United Kingdom and Germany. For the situation in ASEAN, the overall number of cases showed a decreasing trend. However, the outbreak remains high in Vietnam at more than 8,000 cases per day and there was no sign of decreasing its number.

Thailand had 1,960,610 cumulative confirmed cases, of which 6,978 new cases have been confirmed today. There was a decreasing trend of COVID -19 cases in every part of Thailand (around 7,000 cases per day), whereas new confirmed cases were mostly found in central and southern parts of the country, particularly in Bangkok, Samut Prakan, Chonburi, Samut Sakorn and Nonthaburi. The total number of deaths was 19,732 cases (1.01%) and the cases were mostly found in the elderly and people with underlying diseases who had no history of receiving the vaccine or were not fully vaccinated. For the vaccination rollout situation in Thailand, more than 81.7 million doses were inoculated among people with more than 34.7 million people who received 2 doses of vaccines. Even though the rate of people received the vaccine was significantly increasing, the country is still at risk for the COVID -19 due to the reopening country policy and relaxing measures as well as the vaccine provided can prevent the severe symptom and death from the COVID -19, not prevent the transmission of its disease. In the meantime, it was expected that the number of new cases will decrease gradually this week at more than 6,000 cases per day), therefore, there was a need to make surveillance among patients with the suspected symptom, actively investigate the cluster outbreak in risk areas, and encourage people to lift their guide high by wearing a mask, always washing hands, implementing the work from home policy as appropriate, refraining from visiting the risk areas or mass gathering places and getting the vaccine.
