3. Thailand Implementations

- In Yala province, the 1st Border Protection Battalion, Betong, conducts a series of foot surveillance operations. This operation aims to prevent the border smuggling into the city through natural channels. It is intended to prevent the spread of COVID-19 Omicron species entering the country in the Southern Border Area.
- The Civil Aviation Authority of Thailand announced the regulations relating to the guideline for the provision of domestic flight services to passengers. This regulation is in line with the international standard. It does not allow passengers to carry a valve facemask on board. Whereas passengers were encouraged to wear a surgical mask or cloth mask at all times except in emergency situations. It is a matter of minimizing the risk of disease transmission.
- Phitsanulok Province has implemented measures for village leaders and village health volunteers in Ban Mai Rong Kla. It was closed the village for 14 days, starting from 10 - 24 December 2021. As a result, the village will not be permitted to enter and exit to prevent the spread of COVID-19 to other areas. District Public Health

office sent out health workers to active screening in the village for another round to find people infected by the duration of the incubation period.

4. Risk Assessment of COVID-19 Situation

According to the COVID-19 update of December 10, 2021, Thailand had 2,160,780 cumulative confirmed cases, of which 4,193 new cases with 28 deaths were confirmed today. Deaths have mostly occurred in the high-risk group, where symptoms can be severe and lead to death when they become infected with COVID-19. The Ministry of Public Health has recognized the importance of enhancing herd immunity among high-risk Thai and non-Thai populations, particularly after detecting a new strain of COVID-19 (Omicron) e.g. people with seven chronic diseases and pregnant women as well as the elderly aged above 60 years, especially those who reside in the areas of tourist attraction and COVID -19 affected areas. Most importantly, people are encouraged to remain vigilant by strictly adhering to disease control measures, implementing social distancing, washing hands and wearing masks.
